Call to Order

Old Business

1. Mayor Peterson reported that he had contacted Carroll County Fence to obtain an estimate on installing the gate and fence. They are unable to do the work because of health issues. He contacted one or two other fence contractors but they have not returned his calls. As of today, he still has one estimate from Mr. Autry.
2. Terry reported that Gerald Scarborough will continue on the repairs on the gazebo. He had to pressure wash the floor again because of chalk drawings were on the floor. The rain has delayed the work, too.
3. Mayor Peterson reported that the cleanup on the city's property by Sellers Cemetery will be done later this summer or perhaps after the fall harvest as the fields have been planted.

TOWN OF CLARKSBURG, TENNESSEE. Motion seconded by Alderman Etter. Motion approved unanimously.

4. The board reviewed the annual audit provided by Alexander, Thompson and Arnold. Alderman Etter made a motion to approve the annual audit. Motion seconded by Alderman McClure. Motion passed unanimously.
5. Alderman McClure made a motion to approve the financial report for April 2015. Motion seconded by Alderman Etter. Motion passed unanimously.
6. Alderman Etter made a motion to adjourn at 6:22 p.m. Motion seconded by Alderman McClure. Motion passed unanimously.
