

ORDINANCE NO. 03-16-15
CITY OF CLARKSBURG, TENNESSEE

**ORDINANCE PROMULGATING A WEBSITE
USE AND PRIVACY POLICY FOR THE CITY'S WEBSITE**

WHEREAS, the City of Clarksburg has developed a public website for the purpose of providing its citizens and others greater access to various documents adopted by and used by the City as well as useful historical information about the City; now

Therefore, **BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF CLARKSBURG** as follows:

Section 1. This Ordinance shall be known as the **Website Use and Privacy Policy**, and Sections 2 through 6 shall be titled the same and posted on the City's website.

Section 2. By accessing this website, you acknowledge the contents of this Policy. If you do not agree, then you are prohibited from using or accessing this site.

Section 3. The information on this website is provided for the convenience of the user, and we make a good faith effort to ensure that it is accurate and up-to-date. However, no claims, promises, or guarantees about the accuracy, completeness, or adequacy of the information are made. Under no circumstances will the City of Clarksburg be liable for any actions taken or omissions made from reliance on any information contained herein from whatever source. Visitors are encouraged to review the official version of all documents upon which they plan to rely. The official versions are located at City Hall.

Section 4. Some of the linked sites are not under the control of the City of Clarksburg. They are included in the spirit of being helpful to visitors. Therefore, the City of Clarksburg makes no representation concerning their content nor is the City responsible for their content. Further, the link to a site should not be considered an endorsement or an indication of affiliation with the site's owners or publishers. Visitors should be aware that there are inherent risks to using the Internet and should understand these risks before retrieving, using, or relying upon any information found on the Internet.


Section 5. Any information you share with us via the Contact Form or to the Webmaster such as email address, phone, etc. is subject to the

Open Records Act of the State of Tennessee (**Tennessee Code Annotated 10-7-501 et seq**) unless the specific information is exempted from disclosure such as credit card numbers. The City will, from time to time, analyze the website traffic to determine which sites are visited most frequently through the use of Google Analytics. The City of Clarksburg will not share any contact information or data gained through analyses of website traffic with any individual or external entity unless a proper request is made under the provisions of the Open Records Act of the State of Tennessee.


Section 6. Any claim relating to the City of Clarksburg website shall be governed by the laws of the State of Tennessee.
